

## GENERAL TERMS AND CONDITIONS AMRÂTH EARLY BOOKING WEEKS

### ARTICLE 1 GENERAL

- 1.1. The Amrâth Early Booking Weeks by Amrâth Hôtels give you the opportunity, for two weeks only, to reserve a stay with 35% discount on the applicable room rate at the time of booking. This promotion is ideal for a night away, a (long) weekend break, or a longer holiday. The promotional rate consists of a hotel room including breakfast, with the discount applied to the best available rate at the time of booking. An exception applies to Amrâth Apart-Hotel Schiphol Badhoevedorp: here the stay is excluding breakfast and a minimum stay of 6 nights applies.

### ARTICLE 2 APPLICABILITY

- 2.1. These promotional terms and conditions apply to the Amrâth Early Booking Weeks (hereinafter referred to as “the promotion”). By making a reservation during the promotional period, you agree to these terms and conditions.
- 2.2. In addition, the general terms and conditions of the relevant Amrâth hotel apply to every reservation made within this promotion.

### ARTICLE 3 CHANGES AND TERMINATION

- 3.1. Amrâth Hôtels reserves the right to terminate the promotion at any time without prior notice, to limit the promotion to specific dates or room types per hotel, or to modify these promotional terms and conditions during the campaign period.

### ARTICLE 4 VALIDITY

- 4.1. The Amrâth Early Booking Weeks apply exclusively to reservations made via:

- 4.2. Reservations within this promotion can be made from 8 March 2026 until 22 March 2026, for stays between 1 May 2026 and 31 December 2026, and are always subject to availability.
- 4.3. For Amrâth Apart-Hotel Schiphol Badhoevedorp, a minimum stay of 6 nights applies and the stay is excluding breakfast.

### ARTICLE 5 PAYMENT AND CANCELLATION POLICY

- 5.1. Reservations made under this promotion are non-changeable and non-refundable.
- 5.2. The full payment must be made at the time of booking.
- 5.3. Once confirmed, bookings cannot be modified, cancelled, or refunded.

### ARTICLE 6 NUMBER OF ROOMS

- 6.1. A maximum of 10 rooms per hotel per person may be booked during the promotion period.
- 6.2. If more than 10 rooms are reserved for the same date, the hotel may apply the group reservation rate to the number of rooms exceeding 10.

### ARTICLE 7 PRICES AND OCCUPANCY

- 7.1. The listed rates are based on an occupancy of two persons per room.
- 7.2. Single occupancy is also possible.
- 7.3. All prices are inclusive of VAT and exclusive of tourist tax.

### ARTICLE 8 RESERVATION AGREEMENT

- 8.1. Upon completion of a booking, an agreement is established between you and the selected hotel.
- 8.2. The relevant hotel is responsible for the execution of the reservation and serves as the primary point of contact for questions, comments, or complaints.
- 8.3. Payments must be made directly to the hotel.

### ARTICLE 9 COMBINATION WITH OTHER PROMOTIONS

- 9.1. The Amrâth Early Booking Weeks cannot be combined with other offers or promotional discounts.

#### **ARTICLE 10 MISUSE**

10.1. Amrâth Hôtels reserves the right to refuse the promotional rate to individuals who do not comply with these terms and conditions or in cases of suspected misuse or fraud. In such cases, an existing reservation may be cancelled.
